In case of non-receipt of requisite clarifications/ additional information/ supporting documents, such PRA may not be considered in the final list.

Further, please note that in terms of Regulation 36A (11) of the CIRP Regulations, any objection to inclusion or exclusion of a Prospective Resolution Applicant in the provisional list may be made with supporting documents within 5 days from the date hereof, i.e., latest by October 25, 2022.
